Resolution No. 4-2020 City of Clark Fork, Idaho **Fire Department Fees**

WHEREAS, the City of Clark Fork has enacted Ordinance No. 241 adopting the International Fire Code which sets requirements for certain inspections by the fire code official, and Ordinance No. 252 specifying that fees will be set by Resolution, and

WHEREAS, insurance companies require inspections by the fire code official, and

WHEREAS, the City Fire Department incurs costs in performing these inspections if requested, and

WHEREAS, after Public Hearing on July 13, 2020, regarding new fees Inside City Limits, Outside City Limits and Motor Vehicle Accidents, it is deemed by the City Council that the proposed fees are the reasonable cost of providing services and it is in the best interest of the City of Clark Fork and the citizens that the proposed fees which were addressed in the Public Hearing be adopted for the City of Clark Fork.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Clark Fork, Idaho, that the following fees shall apply:

1. Inside City Limits fees for:

a. A fire code plan review for a structure of: 0-1000 sq. ft. 1001-5000 sq. ft. 5001-20,000 sq. ft. 20,001 and up sq. ft.	\$ 100.00 \$ 150.00 \$ 250.00 \$ 250.00 (plus \$50.00 per each additional 10,000 sf)
b. A fire sprinkler plan review (including a compliance inspection)	\$ 150.00
c. A sub-division road site inspection (including a compliance inspection)	\$ 150.00
d. A day care facility inspection	\$ 30.00
e. Special permits (one hour per the International Fire Code minimum	\$ 30.00)
2. Outside of the City Limits Fees:a. Structure Fire (non-subscribers)	\$ 562.00 per hour
b. Wildland Fire (IDL, BLM, etc.)	posted billing rates for specific agency
c. Hazardous Condition call (smoke alarm, propane smell, etc.)	\$ 265.00 per hour
3. Motor Vehicle accident	\$ 500.00 per hour

The minimum fees will be one hour, with additional time based on 15 minute increments.

(this includes traffic control, extrication, etc.)

BE IT FURTHER RESOLVED THAT this resolution shall be in full force and effect upon its passage and approval.

BE IT FURTHER RESOLVED THAT this resolution shall replace Resolution 2-2006, Resolution 2-2008 and Resolution 3-2009 in their entirety.
